Abstract

Hypershares (HYS) is an open-ended blockchain fund pool that tokenizes high-value, yield-generating real-world assets (RWAs), democratizing access to luxury markets traditionally reserved for institutional investors. By combining fractional ownership, blockchain transparency, and multichain interoperability (Ethereum ERC20 and Solana SPL), Hypershares offers investors **fixed returns (15% APY)** and **variable yields (10%–75% APY)** from a curated portfolio of hypercars, business jets, Digital Physical Twins NFTs with nonclonable quantum atomic fingerprintings and other luxury assets e.g. rare limited edition gold watches and kinetic sculptures. Built on institutional-grade infrastructure and inspired by pioneers like Ondo Finance, Hypershares bridges the gap between tangible assets and decentralized finance (DeFi).

1. Introduction

The Future of Luxury Asset Investment

The global luxury asset market—valued at \$1.5 trillion—remains illiquid and inaccessible to most investors. Hypershares revolutionizes this space by tokenizing high-performance assets like Lamborghini Aventadors and Bombardier Global 8000 jets, enabling fractional ownership and passive income through leasing, charters, and asset appreciation.

Why Hypershares?

- Dual-Chain Accessibility: ERC20 (Ethereum) and Solana SPL tokens for speed and low fees.
- **Hybrid Returns**: Fixed + variable yields powered by asset performance.
- **Liquidity**: Trade HYS tokens post 30-day lock-in or redeem for USD, CHF, BTC, ETH, or USDT.
